### **Finding Maindee**

The year began with a successful application to the Arts Council of Wales for funds to research an arts led regeneration programme in Maindee.

We have recently heard that the plans we came up with have led to £364,000 funding for arts led regeneration in our local community. Wow!





### Maindee Front Garden Scheme

We completed our front garden scheme this year. Led by our energetic and enthusiastic project worker, Anita McConnell, the project involved a team of young volunteers who renovated the front gardens of 21 elderly or frail people living in the Jubilee Gardens area of Maindee. The People's Health Trust, who funded the project. have now granted us a small amount of extra funding to continue work with these young people.

### **Woodland Park Dingle Restoration Project**





This year we have been working in partnership with "The Woodlanders", the local park support group we helped to establish as part of the overall restoration project under the enthusiastic leadership of Matt Jarvis.

The Woodlanders have improved the lower path, planted bulbs and sown flower seeds, pruned trees, extracted timber, collected rubbish, got a dragon carved and built and installed a notice board. The project has attracted over a hundred volunteers. This Summer the group, who have just won a RHS award for their work, held their first family event in the park. A great success, especially Matt and Dan's brilliantly simple water slide.

### 2014 Maindee Festival - a nod to this year's World Cup in Brazil

We were fortunate to retain our funding from Newport City Council Arts Development and the Arts Council of Wales and to obtain further funds from the Newport Community Endowment Fund, Community Chest, Sainsbury's Community Fund, Sports Relief Community Cash Fund, and Charter Housing. We also raised money through sponsorship and festival trading.

Maindee "Festiball" was one of our most ambitious street parades to date. Malarky Arts, led by Andy O'Rourke, did a fantastic job of designing and building the stunning giant festiballs and ensuring they could safely be rolled through the streets.

This year instead of holding parade workshops in schools we invited the whole community to attend three days of workshops during the May half term. We also held five a side soccer sessions in the run up to the big day.



The sun shone for us again. Our two stages offered an exciting mix of music, song, dance and eclectic performances from artists including Suzy Condrad, Crime Against Folk, and Alecia Scott, and our new venue the Spoken Word tent, featuring Patrick Jones and Mike Church, was a great addition. Newport City Radio and Urban Circle once again hosted the popular Maindee's Got Talent and we enjoyed a warm and fun day.





Over the Summer we lost Margaret Went, our tireless volunteer coordinator. She died a few weeks after the festival (see picture above). She was posthumously awarded the lifetime achievement award at the Newport Volunteer awards. Another MFA volunteer, Nick Humphries also won

an award for his commitment to the Association at the same ceremony.

## Independent Examiner's Report
